PRACTICE

John McKenna KC has been in practice at the commercial bar in Queensland for over 35 years, including over 20 years as senior counsel. He has a particular interest in appellate matters.

Mr McKenna KC is also a Nationally Accredited Mediator, with over 15 years of experience in the mediation and expert determination of commercial disputes.

Mr McKenna KC was educated at the Anglican Church Grammar School, the University of Queensland and as a Rhodes Scholar at the University of Oxford. He is a Fellow of the Australian Academy of Law, an Adjunct Professor of Law at the University of Queensland, and the President of the University of Queensland Law Alumni Association. He is a former Chairman of the Incorporated Council of Law Reporting for the State of Queensland (2011 - 2024) and a former member of the Supreme Court of Queensland Library Committee (2005 – 2024).

He was awarded a Doctorate of Laws (honoris causa) by the University of Queensland in 2022.

BACKGROUND

Mr McKenna KC was born and educated in Brisbane. He attended the Anglican Church Grammar School (1974-78), where he graduated as dux. He then commenced an Arts-Law degree at the University of Queensland (1978-83), where he graduated with a Bachelor of Arts (majoring in Economics) and a Bachelor of Laws (Hon 1).

In his final year of studies, he was awarded the Rhodes Scholarship for Queensland. Prior to taking up this scholarship, Mr McKenna worked in the banking and finance section of the Brisbane firm of Feez Ruthning (later Allens) and was admitted as a barrister of the Supreme Court of Queensland (17 September 1984).

With the support of both a Rhodes Scholarship and a University of Queensland Travelling Scholarship, Mr McKenna undertook a period of postgraduate study at Magdalen College at the University of Oxford (1984-89). He graduated with a Bachelor of Civil Laws (Hon 1) and undertook a number of years of research into the history and modern expression of the doctrines of estoppel.

In 1989, Mr McKenna returned to Brisbane and commenced practice at the commercial bar. After completing his pupillage, he became one of the founding members of a new set of chambers which was established at Level 16, Quay Central. The other founding members of this group were Judge David Andrews KC, Justice Roger Derrington, Russell Hanson KC, Christopher Hughes KC, John Sheahan KC, Sandy Thompson KC, and Chief Judge Patsy Wolfe. On 20 November 2002, Mr McKenna was appointed to the rank of Senior Counsel for the State of Queensland.

Since this appointment, the primary focus of his practice has been on commercial matters involving legal issues of some complexity. These have arisen from many aspects of commercial activity in Queensland, including from the mining, gas, rail, port, electricity, water, sugar, finance, building, property, education and government sectors.
